Village Green Sign Policies and Specifications

.....

The purpose of this policy is to provide the people of Worthington the opportunity to post public notices of upcoming events and activities in a fair and just manner. Whereas each person has an equal opportunity to post such notices, the City will approve such posting when requests meet the basic requirements of the City.

Permits can be obtained online (in PDF format) at www.worthington.org or at the Community Center customer service desk during regular business hours.

Permits should be submitted at least 3 weeks before the event. Signs are posted for a maximum of 2 weeks.

Signs are posted and removed weekly on Mondays (Tuesdays for Monday holidays). Signs **MUST** be delivered before 7:30 AM on Monday morning, but can be delivered up to 2 weeks prior and must be picked up no later than 2 weeks after the event. The City is **NOT** responsible for damages incurred to the sign while erecting, removing or storing the posted sign. Deliver and pick up signs at the following location (signs should be placed at the south end, or rear of the Center, in the fenced area):

NOTE: We are not responsible for signs left 2 weeks after the event- they may be disposed of by WPRD.

This is a **FREE** public service. Permits will be approved under the following conditions:

1. The sponsoring group is a not-for-profit organization.
2. The location of the activity is in the Worthington area.
3. The sign posted will not be erected more than two (2) weeks before the scheduled date of the event.

Specifications for signs on the Village Green

1. Signs will be single faced, 4 feet wide by 5 feet high (vertical) on one-half inch corrugated plastic or plywood (NO foam core). These 4 x 5 foot signs will slide into the pre-made signboard background. No additional materials, such as vinyl covers or slide-in attachments, can be used or added to the sign.
2. Signs will be located only on the signboards provided and installed by the City.
3. City staff is solely responsible for the posting of signs. Patrons may not post/remove their own signs.
4. Sign permits will be granted on a first come, first served basis. In fairness to all groups, duplicated signs are no longer permitted. Concurrent events from the same organization may be bumped for other groups. Requests for a particular quadrant of the Village Green are not permitted.
5. Any sign can be rejected for structural reasons or inappropriateness.
