### Overview

- Six of the seventeen use of force incidents occurred during 1<sup>st</sup> Shift
- Nine of the seventeen use of force incidents occurred during 2<sup>nd</sup> Shift
- Two of the seventeen use of force incidents occurred during 3<sup>rd</sup> Shift
- Six of the seventeen use of force incidents involved an intoxicated person
- Five of the seventeen use of force incidents involved a person in crisis (mental health)
- Five of the seventeen use of force incidents involved an assault, domestic violence, and/or criminal trespass
- One of the seventeen use of force incidents involved a suspect with outstanding warrants
