SUBJECT: February 2019 Income Tax Collection Update

Please find attached the summary reports for income tax collections for the month of February 2019. February 2019 income tax collections are above February 2018 collections by \$68,217 or 3.44%. Year to date collections are below 2018 year to date collections by \$-180,155 or -4.14%. Year to date actual collections are below year to date estimates by \$-168,010 or -3.87%

Income tax collections are reported as three different account types: withholding, individual and net profit filers. The following table reflects the year to date revenue received from each of the three components – withholding, net profit, and individuals.
