SUBJECT: November 2019 Income Tax Collection Update

Please find attached the summary reports for income tax collections for the month of November 2019. November 2019 income tax collections are above November 2018 collections by \$207,293 or 11.05%. Year to date collections are above 2018 year to date collections by \$277,747 or 1.14%. Year to date actual collections are above year to date estimates by \$304,935 or 1.25%.

Income tax collections are reported as three different account types: withholding, individual and net profit filers. The following table reflects the year to date revenue received from each of the three components – withholding, net profit, and individuals.
