SUBJECT: Income Tax Collection Update for March, 2012.

Please find the summary reports for income tax collections for the month of March, 2012 attached. Income tax collections for March, 2012 are above March, 2011 collections by \$224,824 or 17.52%. Year to date collections are above 2011 year to date collections by \$265,605 or 5.98%. Actual collections are above year to date estimates by \$25,694 or .55%.

Income tax collections are reported as three different account types: withholding, individual and net profit filers. March, 2012 collections were above the prior year reporting for all account types. The breakdown of collections for the month of March, 2012 is indicated below:

- Withholding accounts equate to 89.18% of collections
- Individual accounts equate to 5.21% of collections
- Net profit accounts equate to 5.61% of collections.
