SUBJECT: Income Tax Collection Update for June, 2012.

Please find the summary reports for income tax collections for the month of June, 2012 attached. Income tax collections for June, 2012 are above June, 2011 collections by \$232,698 or 12.66%. Year to date collections are above 2012 year to date collections by \$818,888 or 8.19%. Actual collections are above year to date estimates by \$276,261 or 2.62%. Year to date refunds total \$178,640 and are \$88,814 below 2011 refunds.

Income tax collections are reported as three different account types: withholding, individual and net profit filers. June, 2012 collections were above the prior year reporting for net profit filers and below for withholding and individual account types. The breakdown of collections for the month of June, 2012 is indicated below:

- Withholding accounts equate to 70.49% of collections
- Individual accounts equate to 19.13% of collections
- Net profit accounts equate to 10.37% of collections.
