SUBJECT: Income Tax Collection Update for November, 2012.

---

Please find the summary reports for income tax collections for the month of November, 2012 attached. November, 2012 income tax collections are above November, 2011 collections by \$94,170 or 6.23%. Year to date collections are above 2011 year to date collections by \$1,513,395 or 8.40%. Actual collections are above year to date estimates by \$537,984 or 2.83%. Year to date refunds total \$768,275 or 3.93% of total income tax collections. 2011 refunds totaled \$530,669 as of November 30, 2011 or 2.95% of total income tax collections.

Income tax collections are reported as three different account types: withholding, individual and net profit filers. November, 2012 collections were above the prior year reporting for withholding and net profit accounts and below for individual accounts. The breakdown of collections for the month of November, 2012 is indicated below:

- Withholding accounts equate to 73.70% of collections
- Individual accounts equate to 18.88% of collections
- Net profit accounts equate to 7.42% of collections.
