SUBJECT: Income Tax Collection Update for March 2013.

Please find the summary reports for income tax collections for the month of March 2013 attached. Income tax collections for March 2013 are above March 2012 collections by \$20,559 or 1.365%. Year to date collections are above 2012 year to date collections by \$324,836 or 6.90%. Actual collections are above year to date estimates by \$254,210 or 5.32%.

Income tax collections are reported as three different account types: withholding, individual and net profit filers. March 2013 collections were above the prior year reporting for withholding and individual account types and below for net profit accounts. The breakdown of collections for the month of March 2013 is indicated below:

- Withholding accounts equate to 93.73% of collections
- Individual accounts equate to 6.27% of collections
- Net profit accounts equate to 0% of collections.
