Notes: The aggregation performed very close to AEP Ohio's default rates this past summer while offered a 100% Renewable offset product. We do expect performance to decline slightly for October - December due to a slight drop in AEP Ohio's rates. The average residential customer would pay 5.144¢ for Oct-Dec with AEP Ohio while they will/have paid 5.186¢ on the aggregation. However, we expect strong performance to return in January when AEP Ohio's residential rate increases to 5.3¢.
